Carpenter made motion to accept hiring recommendation for summer help from Mulholland. MSB Mulholland. Ayes: Carpenter, Mulholland, Wilson. Nays: Morahan, Price. Motion carried.

Carpenter made motion to approve a proposed addition of master bedroom and bathroom to the primary residence at 1174 Knapp Road. MSB Mulholland. Wilson-Aye; Mulholland-Aye; Carpenter-Aye; Morahan-Nay; Price-Nay. Resolution R-04-2021 passed.

Wilson made motion to approve CR WPC First Addition for Alliant Energy Substation on Berry Road. MSB Mulholland. Wilson-Aye; Mulholland-Aye; Carpenter-Aye; Morahan-Nay; Price-Nay. Resolution R-05-2021 passed.

Carpenter made motion to approve G&M Fourth Addition to split 10-acre plot with primary residence from remaining farmland. MSB Wilson. Wilson-Aye; Mulholland-Aye; Carpenter-Aye; Morahan-Nay; Price-Nay. **Resolution R-06-2021** passed.

Council reviewed the only approved bids for derecho repairs to City Park shelter, pump house, and City Hall/Shop.

Wilson made motion to reject the bid for the City Park shelter and send out for rebid. MSB Carpenter. Ayes: Carpenter, Mulholland, Wilson. Nays: Morahan, Price. Bid rejected.

Carpenter made motion to accept Madsen Custom Homes proposal of \$43,196.21 for repairs to City Hall/Shop per RFB, contingent upon a Terms and Condition modification of paragraph 3 to: "Upon mutually agreed-upon completion of the proposed work, invoices submitted by 5:00pm CT the First Wednesday of the month for payment within 30 days". MSB Wilson. Ayes: Carpenter, Mulholland, Wilson. Nays: Morahan, Price. Bid accepted.

Carpenter made motion to accept Madsen Custom Homes proposal of \$4,137.38 for repairs to the pump house per the RFB, contingent upon a Terms and Condition modification of paragraph 3 to: "Upon mutually agreed-upon completion of the proposed work, invoices submitted by 5:00pm CT the First Wednesday of the month for payment within 30 days". MSB Wilson. Ayes: Carpenter, Mulholland, Wilson. Nays: Morahan, Price. Bid accepted. A fourth proposal for siding replacement, fence repair and tree removal within the fenced area surrounding the pumphouse was not approved.

Wilson made motion to set a public hearing for Wednesday August 11, 2021 at 6:00pm to review the Land Use Plan and get public input. MSB Carpenter. Ayes: Carpenter, Mulholland, Wilson. Nays: Morahan, Price. Motion carried.

A floodplain ordinance needs to be approved by 7/20/2021. It requires a public hearing before council can vote. Council asked City Attorney to use broader language in the draft ordinance. Tentative public hearing will be at the June council meeting.

Correspondence: State DOT will be completing patchwork on Highway 13 in near future. Trees have been received from DNR and will be handed out to residents Thursday 5/6/2021 from 1:00-4:00pm at City Hall. Tires on blue truck need to be replaced, Public Works employees to complete. Insurance adjuster returned to view additional damages discovered at City Hall and pumphouse. Next Lower Cedar WMA meeting is scheduled for 5/11/21. It is unlikely Bertram will receive much funding for the water study due to limited availability.

Open to Floor: Life Time Fence will begin installation of fencing at City Park along the lot line with UPRR in late May/early June; surveyors have already completed their tasks and lot markers were put into place (though should be replaced with something more permanent). Bertram City Limit sign at north end of town on Bertram Street needs to be picked up and replaced, as well as a sign in Rustic Ridge. Suggestion to add a marked crosswalk for pedestrians from City Park to the disc golf course. New playground looks great! Need to get old equipment removed and disposed of. New flagpole looks good.

Carpenter made motion to adjourn. MSB Wilson. Ayes: Carpenter, Mulholland, Wilson. Nays: Morahan, Price. Meeting adjourned at 8:32 PM.
