Land Use Plan Update: Several surveys have been received by City Clerk. Surveys will remain unopened and will be taken to ECICOG for tabulation by Carpenter. Public input session is scheduled for August 11, 2021.

Correspondence: Lower Cedar WMA meeting is 8/10/21 and there may be more info concerning Big Creek studies. Insurance adjustor has assessed additional damages at the pump house and additional claim amount has been submitted. Roof repairs at City Hall and pumphouse to begin 6/3/21. City to once again look into UTV ordinance for use within city limits. Need to install benches or picnic table closer to playground and basketball hoops need repair. City employees to attempt to dismantle and remove old playground equipment.

Open to Floor: Restrictions for open council seat is 18 years of age or older and must be a current resident of Bertram. City to look into expanding city hall parking lot to the east lot line.
