Linn County Solid Waste Agency is beginning the process of finding a location for a new landfill. They are working with an engineering firm to determine best practices and new technologies for the new landfill. Based on current capacity and average waste hauling metrics, the existing sites will fill up by mid-2044. All information and updates are available on their website: https://www.solidwasteagency.org.

1221 2<sup>nd</sup> Street had a building permit open for two years to build a new garage, but have not been able to complete the project. They are unable to renew the permit again and the County cannot issue one because part of the building is on a city easement. P&Z Committee has recommended that the Council vacate the easement (property owner owns all surrounding parcels). Home owner to get abstract to City Attorney to review to make sure there the Assessor's Office didn't miss something. City to pursue vacation of the easement, if necessary.

There are three additional trees in the ROW in Rustic Ridge that need to be trimmed. There may be more on Skylark. Council chose to table conversation until Item #12 Pump House Trees Outside the Fence.

Caraways were asked by Price to bring a proposal before the Council of regarding the roadway in front of Lots 16 & 17 of Rustic Ridge. They were unable to attend the meeting. Item tabled.

Wilson was able to obtain only one quote for a larger LP tank for the pump house. The quote was from Linn Co-Op for a 1000-gallon tank for \$4,375 pus \$100 each for first and second stage regulators and \$4.00/foot of trench (if needed). Wilson to check on options of plumbing in a second smaller tank in tandem with existing tank. No action at this time.

One quote was received from Country Arborists to remove four large and eleven small trees outside the fence at the pump house for \$8,474.40. Wilson is trying to get the cost of the four large trees itemized and have city employees take down the small trees. Item tabled until December meeting.

No new quotes received for pump house fence replacement. Need to solicit three comparable quotes for fence replacement and haul away of old fencing.

Unzeitig received a quote from WT Group for \$9,001 to perform and audit and provide a barrier removal plan to meet ADA requirements in City facilities. Council questioned whether or not there are grant options available. Tabled until December meeting.
