- Update on City Truck Purchase: Council Member Unzeitig asked if Blue Truck would make it through the til spring. Will probably get better price. Tony Vislisel stated it probably would. Council Member Price believes the city could use a 2500 trucks or 3500 with a dump box or chassis and have Futureline frame it out. City plans to get a newer truck and sell the Red Truck that requires a CDL.
- Salt and Sand Budget and Need: Mayor Flaherty stated we have salt for one more go round of snow.
 Used 3 loads last year. Suggested to order 1 load and have Marion Deliver. Marion is using only salt to be more environmentally friendly.
 - Price makes a motion to approve up to \$4,500.00 for a purchase of salt from City of Marion with delivery. MSB: Hall. AYE: Hall, Klimek, Mulholland, Price, Unzietig. Motion passed by unanimous vote.
