- Update on ClerkBooks-Software has been downloaded and Lisa Berry (treasurer) and Raven Kuehl (Clerk) have started training and used the program.New Siren Installed

Council's direction for pursuing City Ordinance violations – City previously submitted survey to residents to determine what they wanted and number 1 was better streets number 2 was appearance of town. The city has a nuisance ordinance in effect and it needs to be enforced. If a complaint is made the council need to act on it. City Attorney stated informal procedures have been address at this stage need to move to enforce formal violations.

Cameras at City Hall - Sheriff recommendation, will be installed in parking lot shortly.

Verizon Internet/phone. City is currently on a residental plan, business plan offers more benefits, no activation fees, better retuen window, better insurance. Can keep same speed as currently but have more data, for close to same price.

Klimek made motion to move to Verizon business account at lower speed. MSB Hall Motion passed by unanimous vote

Sidewalks vs No sidewalks. For the storm water options: for the same area of Angle to 2nd all the way to Ely Street removing humps with open ditch culverts estimate is \$275,000, for a flat with curb and cover estimate is \$515,000 and doesn't include the cost of the sidewalk. Council is tabling at this time.

Platting review/identifying ROW-Total estimate in reference to Fehr Graham report is\$17,500 for the surveying. Estimate is pure time and material, first couple properties will be most expensive, the more assistance city can provide for where pins are will lower cost. This serves to help with vacating of alleyways and stormwater project. Due to amount of estimate this will have to have multiple bins. Price will work on getting additional bids. Council tabling vote until January. Council feels it is in city best interests to acquire a metal detector. Unzeitig will contact Acme Tools.

Storm Water City worker Zach Zuzich can run a backhoe. Looking into funding to turn into wetland.

Updated draft 28E Water/Sewage Township Hall. Tabling for updating the water ordinance.

Update on tree removal. Remove two large stumps at City Hall and backfill \$1,840.00,Grind stumps next to Pump House \$1,560.00,Cleanup and backfill where stumps were to right of Pump House \$1,840.00,Remove all trees within 15 feet of left side of Pump House \$920.00.

Hall made motion to approve tree work. MSB Carpenter Motion passed by unanimous vote

Update on Annexation and bridge-County plans to help with engineering costs as long as it is approved state bridge. Grant to replace bridge does not cover the engineering cost. Hopefully know by end of December if a state approved bridge is possible. Unzeitig and Price setting up meeting with county to find out if land

acquisition is needed and what the potential income and cost is. Waiting to see what the maintenance cost of gravel and Council is working to make the best financial decision for the city and its residents.

Windshield blue truck-has micro scratches. If safety issues needs to be. Motion to replace windshield.

Klimek made motion to approve replacing windshield on blue truck. MSB Hall Motion passed by unanimous vote

## Correspondence-

- Price feels Mayor Wilson is doing a phenomenal job, she has been working on getting multiple grants for the betterment of the City. Decision made by the
  Mayor and Council are made in the best interests of the city and residents and in compliance with State and Federal Laws. Decisions have to be made in
  compliance with the guidelines provided to avoid fines and fees.
- Bonding-Council wants to look at anyone who handles money to be bonded at a minimum of \$100,000, if the cost for bonding is per person. Council will
  need to set a dollar amount.

## Open to the Floor -

- Carlise Bys-State original platt map is in the office, unsure what markers were used to mark lots then. Price stated the platt map is also available online.
- Chad Dummermuth-Would like sidewalks removed if not ADA approved, does not think that sidewalks would be beneficial to the city. Be cautious with Annexation and hunting within city limits. Wants to know if city is for the bike trail, would prefer not, he does not plan to allow the bike trail to go through his property. Cautioned to be careful with finding platt lines as might find that thinks are not located on the correct property. Price stated that he is looking into state rules for hunting within city limits and that for city sewer water system will have to eventually be found.
- Jon Kaut- Will City of Bertram be in charge of snow plowing the possible annex roads. Price stated working on potential 28E agreement with County to assist with snow plowing and looking into what the long term maintenance would be.

Price made motion to adjourn. MSB Carpenter. Vote to adjourn: Aye: Carpenter, Hall, Price, Unzeitig, Klimek. Meeting adjourned at 8:47 pm.
