- ECICOG Planning and Zoning Proposal- Council Member Price stated that the planning and zoning has not been updated since 2004, attempted to update in 2020, but was not completed. City Attorney Shea is not able to do this at this time due to multiple large cases. Planning and Zoning will be unable to approve permits and will have to send almost everything to the Board of Adjustments, also needs to be updated for Fringe agreements.
 - Hall makes a motion to approve contingent on City Attorney Shea approving due to purchasing policy. MSB: Klimek. AYE: Hall, Klimek, Mulholland, Price. Motion passes by unanimous vote.
- 1300 Skylark-P and Z update: Robert Hebler wants to put a carport. P and Z is recommending denial due to violation of zoning setbacks.
 - Price Makes a motion to deny based on current zoning codes. MSB: Klimek. AYE: Hall, Klimek, Mulholland, Price. Motion passed by unanimous vote.
- Ashley Tree Service bids: Nothing to discuss.
- Skyline Drive Tree Service Bids:
 - That Girl Tree Service: \$2,050 for 2 trees won't touch the 3rd tree.
 - Franks Tree Service: \$3,500 for all 3 trees and haul away.
 - D&D Tree Service: \$3,800 for all 3 trees.
 - Price makes a motion to approve Franks Tree Service to remove trees. MSB: Klimek. AYE: Hall, Klimek, Mulholland, Price. Motion passed by unanimous vote.
- 1850 Woodland Court-Planning and Zoning Approval: Smejkal requesting approval for new dwelling well over minimum square footage and setback is correct. Is also in zone r1, which does have 2 acres minimum but using opinion of city attorney using should not in ordinance. P and Z is recommending approving with stipulations that 3 trees are removed per recommendation of Certified Arborist That Girl Tree Service.
 - Mulholland makes to accept with trees. MSB: Hall. AYE: Hall, Klimek, Mulholland, Price.
- Hiring Committee for new Bertram Treasurer: Tables to next meeting.
- Snow Plowing update: Big Red requires a CDL and currently no one has one. Blue Truck does not.
- Correspondence:
 - Hall: Tree on Ely and Bertram Street was approved for Franks Tree Service to remove but Franks cannot due to powerline and Alliant will not take down. Louise is looking into different bids.
 - Price: Doug Kula is on Board of Adjustments and term ends October 4, 2024, need to see if he wants to continue or find someone else.
 - Price: Needs someone else on P and Z to have a full board.
 - Price: Needs to make a decision at next council meeting if closing the bridge again for winter do to the weight limit and safety.
- Open to public:
 - Penny Kula: Would like the council to add resealing all roads and paint lines in the 2026 Budget.
